SPRINGBROOK RULES AND REGULATIONS OF MEMBERSHIP

By signing below, you hereby recognize and agree to the following rules and terms of membership and agree that breaching or violating any one of the following may result in the evaluation of said violation and may be followed by a written warning. You recognize and agree that if your membership becomes invalid that you may still be liable to the club for damages and/or membership dues: ABSOLUTELY NO OUTSIDE FOOD OR BEVERAGES ARE ALLOWED.

1. Type of Membership: \_\_\_\_\_

1. Membership Rules:

1. Memberships that include a CART PLAN shall be defined as the use of ONE cart per outing for the membership plan. Additional carts used under the same membership plan shall be charged the customary cart rate for the number of holes.
2. Membership Commitment: The member agrees that this membership shall last a minimum of 1 year. Unless membership is a seasonal membership. The member acknowledges that in consideration for the commitment to this membership length, list if the member was given any special allowances.

2. Damage to carts: You shall not damage or in any way use carts for any purpose not authorized by the operating instructions on the cart. Paying for any damages caused by you while operating carts will be the responsibility of the member responsible for the damage or the member that is the primary member on the account if the damages are caused by a minor or other authorized user of the member's account and/or membership.
3. Damage to the golf course: Damages caused by intentional or negligent actions by the member that are not normal wear and tear will be the responsibility of the member to repair or pay for the cost of repair, whichever the club decides is in the best interest of the golf course.
4. Damages in the Member's Activity Room: All members shall be responsible for any damages caused by their negligence or misuse of all equipment in the member's activity room, including, but NOT limited to: Simulators, Televisions, Sound System, Furniture, Furnishings, or any other items.
5. Damages to the Clubhouse: All members shall be responsible for any damages caused by their negligence or misuse of the Clubhouse. Including, but not limited to: patio chairs and table, table clothes, and any and all furniture.
6. Monthly, Quarterly, Semi-annually or Annual Dues and Charges: You understand it is your responsibility to stay current with your account and keep your account in good standing.
7. Notice of Cancellation: 30 Days written notice of your intent to cancel your membership is required. Your notice should include the last month you intend to use your membership. You shall be charged for the month following your notice if you do not fulfill your full 1 year minimum. You shall not have any charging privileges during the last month of your membership. You will not have charging privileges unless you make a request to have them and it is granted. All account charges must be paid prior to the expiration/cancellation/termination of the membership. The member hereby acknowledges if there is an outstanding balance at the conclusion of the membership, the club may continue to bill member for periodic dues until account is brought current. If Member has prepaid for dues and cancels said membership prior to the expiration of the said prepaid dues, member understands that any prepaid dues could be forfeited. In the event there are extenuating circumstances, management will review and if cancellation is justified, the member would only be responsible for the next month's dues. If cancellation occurs prior to meeting one year commitment obligation, member must wait for one year (or longer) from date of resignation. If member joined in a "waiver of initiation fee period" they will be responsible for that fee (\$ 1,500.00).
8. Guests: All members are responsible for the damages caused by their guests.
9. Delinquencies: If any account balances are unpaid within 30 days of due date, then you hereby acknowledge and agree that unpaid balance will be charged to above credit card. If the unpaid balance is not collectible through these means, and no other arrangements have been made with management within 60 days, all charging privileges shall be revoked; within 90 days, all privileges of membership will be suspended and members account will be placed under review.
10. Collections: If the club has to retain counsel to recover any damages or outstanding balances after numerous attempts outlined above, the member agrees to pay the club reasonable attorney fees of the outstanding balances or damages. The member agrees that jurisdiction for any lawsuit filed shall be McMinn County and the State of Tennessee.
11. Special Provisions:
  1. Decorum
    1. Dress Code - By signing this, below member(s) understand and agree to uphold standards of attire and dress accordingly for ALL events at said club. Members agree to dress appropriately while attending any and all club functions, inside or outside of the club, while on club property. This includes but is not limited to: golf shirts (collared, polo style shirts), and hemmed shorts or dress slacks or pants and/or skirts for ladies. Jeans are ONLY ALLOWED from NOVEMBER 1 - MARCH 30. Members will be informed of the infraction upon 1st violation of the dress code, any subsequent infraction will result in a written notification of infraction.
    2. Derogatory or Disparaging Comments – Members agree not to post any comments or materials that could harm the club's reputation on any media platforms. Member(s) understand that action may be taken for a violation of this section. If suspension of membership, after review, is deemed appropriate by management, member agrees that their account/membership may be affected.
